THIS MATTER came before the undersigned Commissioners of the Washington State Gambling Commission ("Commission") at the Commission's regularly scheduled meeting on January 10, 2013, in Tumwater, Washington on Certification Holder Delia A. Jones's Motion to Vacate the Commission's previously entered Findings, Conclusions and Final Order in Default ("Final Order In Default"). Ms. Jones did not appear and no one appeared on her behalf. Assistant Attorney General Stephanie U. Happold represented the Washington State Gambling Commission's agency staff. 

IT IS ORDERED that Delia A. Jones's Motion to Vacate the Final Order In Default is DENIED.


