FINAL ORDER ON

THIS MATTER came on for hearing before the undersigned Commissioners of the Washington State Gambling Commission at the Commission's regularly scheduled meeting on January 12, 2012, in Tumwater, Washington, on Licensee J & D Millennium, Inc's. (d/b/a Jet Bar & Grill) Petition for Review. The Licensee was represented by its President and part owner, Stephen A. Dorn. Agency staff were represented by Assistant Attorney General Stephanie U. Happold. The Commission had before it the entire record of the proceedings before the Administrative Law Judge, as well as additional pleadings prepared for the presentation of the Petition. Following argument and review of the record, the Commission finds that the record in this matter is sufficient to support the Findings of Fact, Conclusions of Law and Initial Order of the Administrative Law Judge and hereby Orders as follows:

IT IS ORDERED that the Administrative Law Judge's Findings of Fact, Conclusions of Law and Initial Order heretofore made and entered in this matter be, and the same hereby are,

AFFIRMED and, further, that they are hereby incorporated into this Order by reference and adopted as the Findings of Fact, Conclusions of Law and FINAL ORDER of the Commission; and,

IT IS FURTHER ORDERED that the license to conduct gambling activities previously issued to J & D Millennium, Inc., d/b/a Jet Bar & Grill is, accordingly, HEREBY REVOKED.
