## **Public Session Call to Order**

**Chair Sizemore** called the Gambling Commission to order at 9:07 a.m. and welcomed everyone to the Hampton Inn and Suites. He announced that Commissioner Stearns was out of town on business and there would only be three Commissioners for this meeting. He welcomed Assistant Attorney General, Matt Kernutt back to the Gambling Commission and other introductions were made.

Chair Sizemore asked for a moment of silence for those law enforcement officers across the country that were lost in the line of duty.

There were 27 people in attendance.

## Consent Agenda:

Commissioner Patterson moved to approve the consent agenda as presented, which includes the Snoqualmie Class III certification.

Commissioner Troyer seconded the Motion.

The Motion passed. 3:0

### **Director's Report**

**Director Trujillo** introduced one of the newest members of the Gambling Commission, Ms. Faith Peterson. Ms. Peterson was hired in January as the Office Assistant III to support the Professional Standards & Training Unit. The Gambling Commission received a request to negotiate an amendment to the Suquamish Tribe's Gaming compact on January 29<sup>th</sup>, 2018, from the Governor's office. A meeting with the Suquamish Tribe will be scheduled later in February.

On February 6<sup>th</sup> the Gambling Commission went through an onsite re-accreditation review by representatives of Washington Association of Sheriffs and Police Chiefs (WASPC). The Gambling Commission passed re-accreditation and will receive their award in May at the WASPC Spring Conference. Director Trujillo updated the Commissioners on the U.S. Supreme Court decision that is pending on sports betting and mentioned that at least 15 states are moving some form of sports betting legislation in anticipation of how the Court may rule. He said that Kentucky and Nebraska are looking to constitutional amendments to authorize other new forms of gaming and New Jersey has five (5) casinos that operate 23 iGaming sites. He also added that the state of Indiana has a "loot box" bill scheduled for a hearing on the same day Washington legislature is scheduled to hear a similar "loot box" bill. Director Trujillo gave a brief background on loot boxes stating New Zealand is currently saying loot boxes are not gambling, but that Belgium is contemplating banning loot boxes throughout Europe. Director Trujillo reminded everyone that March is Problem Gambling awareness month and that Evergreen Council on Problem Gambling will be posting events on their website. The National Council has published a tool-kit guide for the month that includes goals, objectives, weekly themes, and March 13th has been declared Gambling Disorder Screening Day. Lastly, Director Trujillo introduced the Interim Director of the Washington State Lottery, Marcus Glasper, and welcomed him to the meeting.

Chair Sizemore applauded the staff for their work on the reaccreditation process.

## **2018 Legislative Update**

**Legal and Legislative Manager Brian Considine** presented the materials in Tab 1. Mr. Considine spoke about the 2018 legislative session and the bills specifically linked to the Gambling Commission. Mr. Considine announced that session is a little more than half way through and highlighted a few bills that could impact the Commission.

Mr. Considine shared that EHB 2332, self-exclusion for problem gamblers, is supported by the Commission and it was passed out of the House, 94-3, on January 24, 2018, with an amendment. Staff does not have any concerns about these amendments at this time. He thanked Commissioner Patterson for attending the HB 2332 hearing. Commissioner Patterson expressed her concern over HB 2332 getting lost in a long list of bills. Mr. Considine assured Commissioners that he will try to get it out of committee as soon as possible and added that he Director Trujillo met with Senator Nelson to brief her on the self-exclusion bill.

**Mr. Considine shared that HB 2881** criminalizes the operation of an online website or platform that facilitates, or is used to facilitate, an unauthorized gambling activity. The bill makes it a Class C felony for a person to knowingly facilitate an illegal gambling site where using virtual items are used as things of value.

Mr. Considine said that SB 6266 identifies the use of video game "loot boxes" as a topic that the Commission should investigate and determine if it is gambling. Loot boxes are a digital "box" or "grab bag" that video game players have to spend real or in-game currency on. SB 6266 requires the Commission to conduct a study and report to the Legislature by December 1, 2018 on the following topics: (1) Whether games and apps containing these mechanisms are

considered gambling under Washington law; (2) whether these mechanisms belong in games and apps; (3) whether minors and other young people, who may be more vulnerable to gambling addiction, should have access to games and apps with these mechanisms; and (4) the lack of disclosure and transparency with respect to the odds of receiving each type of virtual item.

Mr. Considine added that he and Director Trujillo met with Senator Ranker to discuss this bill. Senator Ranker is very concerned about the use of loot boxes and has discussed them with several company leaders within the gaming industry. A hearing occurred on January 31, 2018 in the Senate Labor and Commerce Committee. Mr. Considine added that Commissioner Stearns, Director Trujillo, testified on the bill taking a neutral stance on the bill since the Commission has not voted on a position. However, Senator Ranker asked for the Commission's support on the bill.

**Commissioner Patterson** asked for more clarity on a virtual "box" that can be found on a video game and asked if Mr. Considine could articulate how one might conclude that this is gambling. **Mr. Considine** explained that there are three common elements: consideration, chance, and prize. The commonality of concern for the Gambling Commission is skins essentially can be monetized. It is acting like a currency.

**Commissioner Troyer** cautioned the Commission on this topic saying is sounds like a cryptocurrency for teenage kids.

Mr. Considine recommends that the Gambling Commission support this bill with two caveats:

1) to amend the bill to include skins, and 2) the Gambling Commission conduct a study to gather stakeholders feedback, and come up with a report that support the recommendations going into the 2019 legislative session. The Gambling Commission estimates \$80,000 to \$100,000 for such a study and would ask a third party to conduct the study. Mr. Considine suggests that the Gambling Commission ask for appropriations from the legislature for the cost of the study and recommends support of the bill with the two caveats. Mr. Considine mentioned the Gambling Commission has received complaints on skins. Chair Sizemore agreed that the Gambling Commission should increase the knowledge base regarding technology and believes that our role will be tested in the future because of issues like "skins" and "loot boxes."

Commissioner Troyer moved to approve to support Senate Bill 6266 as recommend by staff to include the studying of skins and an appropriation from the legislature.

Commissioner Patterson seconded the bill.

The bill passed. 3:0

**Mr.** Considine shared that **HB 2416** had a hearing in House Commerce and Gaming on January 16, 2018 and he and Director Trujillo testified on the bill; this bill did not get out of committee. He also shared that **ESSB 5671** is unlikely to move out of the Senate and did not believe any new vote by the Commission was warranted at this time.

## **Law Enforcement Bills**

Mr. Considine said that SHB 2718, Representatives Shea and Goodman's bill, addresses civil forfeiture standards and reporting and that we continue to monitor the bill but recommend taking no action at this time due to the likely minimal impact the bill will have on the agency.

Mr. Considine **added that I-940** was certified by the Secretary of State and it is now filed with the Legislature. The legislature has three options during the 2018 session: (1) adopt the initiative as proposed, with no amendments, and it becomes law without a vote of the people; (2) no action and the initiative will be on the November 2018 general election ballot for a vote of the people; or (3) enact a different bill on the same subject and the bill and initiative will be on the November 2018 general election ballot for a vote of the people. Mr. Considine indicated that the Legislature is not likely to pass this initiative as a bill or pass a competing bill with a different criminal standard and training requirements at this time and I-940 will likely be put to a vote of the people during the November 2018 general election.

Mr. Considine reminded those present that the **Problem Gambling Legislative Work Session** is tentatively scheduled for February 19, 2018, from 1:30 p.m. to 3:00 p.m. and Commissioners Patterson and Stearns along with Director Trujillo will participate in the work session.

Finally, Mr. Considine closed by announcing that Commissioner Sizemore and Commissioner Patterson had confirmation hearings in the Senate Labor and Commerce Committee on January 17, 2018. The Labor and Commerce Committee voted to confirm both Commissioners. They are now on the Senate Confirmation Calendar and will likely be confirmed by vote of the full Senate sometime in the next few weeks. He said he would continue to work on the confirmations for Commissioners Troyer and Stearns

### Petition for New Rule - Texas Hold'em Poker

Assistant Director (AD) Tina Griffin presented the materials for Tab 3. The petitioner is seeking to make changes to WAC 230-15-135, wagering limits for nonhouse-banked card games. Currently, the card room licensees that offer poker games can offer a game with no more than five betting rounds per game, no more than four wagers for betting round, and single wagers of no more than \$40 for Class E card rooms and \$300 for Class F and house-banked card rooms. The petitioner is seeking to eliminate the restrictions on the amount of the wagers and eliminate the number of wagers allowed in the betting rounds. The petitioner, Mr. Christopher Hancock, joined AD Griffin and explained to the Commissioners why he thinks the wagering limits should change. Mr. Hancock stated that Washington State does not have legal No Limit Hold'em. It

has something that looks like No Limit Hold'em. The singular defining characteristic of No Limit Hold'em is that at any point in the hand you or your opponents can put their entire stack of chips in play. This shapes the mathematics of the game. It is the essence of the game. The mere possibility that the next bet can be for your entire stack of chips shapes how you approach each and every hand. It is what gave the game its nickname the "Cadillac of Poker." The prescriptive rules mentioned were two specific ones. First, the restriction on the number of bets in a given round of betting is capped at four. Second, the size of any given raise or bet is capped at \$300. This, he believes, is the more egregious of the two rules. These restrictions restrain players in alltoo-frequent circumstances from performing some of the essential strategic tasks in the game. The flexibility to make a bet of a size that denies the opponent the proper odds to continue in the hand with a positive expected value is key. The current rules prohibit this in many circumstances. The nature of the Cadillac of Poker he described is absent from what casinos and card rooms in Washington misleadingly call No Limit Hold'em. What is played here in Washington is something functionally more like Spread Limit Hold'em, which is a vastly less popular form of the game that is played almost exclusively in areas where regulations prevent no Limit Hold'em from existing. An indicator of how unpopular this form of the game is that there is no World Series of Poker event for Spread Limit poker despite the fact that there are well over 60 events held at the World Series of Poker. In some reasonably frequent circumstances, he thinks these rules achieve the opposite of their intended ends, leading players to lose more money than they otherwise would. The restrictions create circumstances where it's mathematically impossible for the player with the best hand to play correctly because he or she has been deprived of the ability to shape the size of the bet appropriately to the size of the pot. When this happens, when the player with the best hand cannot mathematically play the game correctly, the game is no longer a game of skill. It is more akin to a lottery and in many circumstances, the rules unintentionally encourage reckless play. This is not good for social welfare. There are four rounds of betting in a hand of Hold'em, and if players were to make the maximum bet size of \$300 for each of the four bets on four rounds of betting, a player could theoretically lose something close to \$4,500 in a given hand. His understanding is that the restrictions of four bets per betting round times and \$300 per bet was to limit losses to \$1,200. If the goal was to limit losses in a given hand to \$1,200, the current rules do not achieve those ends. The maximum bet size is not the appropriate unit of analysis. The Commission should completely abandon concerns about bet size, at least in the scope of this particular game. There is a much simpler, less intrusive way to abide by the principle of limited scope and nature while also letting the game breathe. The Commission should simply restrict the maximum buy-in from a given player to \$1,200 in any game of No Limit Hold'em. In a proper game of No Limit Hold'em, in a given hand, a player can only lose what is in front of him or her or, more precisely, a player can only lose what's in front of him or her or what's in front of his or her opponent, whichever is smaller. A simpler way to put this is that in an actual game of No Limit Hold'em, the maximum bet size is the amount of money the player has in front of them. If the Commission wants to limit losses to \$1,200, it will have effectively done so if it simply restricts the size of the buy-in to \$1,200. Restricting the buy-in to this size would do just as good of a job of achieving the Commission's goals as the current rules but without spoiling the nature of the game. Changing the current rules to the rule proposed would also allow casinos and card rooms to offer a greater selection of poker games. It would also keep Washington players that are serious about the game in Washington casinos and card rooms rather than sending them elsewhere. And it would let Washington play the game that was meant to be played. To summarize his complaint here isn't simply that the current rules produce a much less exciting and interesting game, although that is very much true, his complaint is that the current well-intentioned rules destroy

the very nature of the game, encourage reckless play that otherwise wouldn't occur, and encourages players like myself to leave the state when the itch to play the game arises. Commissioner Troyer inquired on a \$1,200 dollar bet and asked if a player had a \$1,200 buy-in and somebody gets on a roll and has \$4,000 to \$5,000 dollars sitting in front of them as a bet, can that person put that whole \$4,000- \$5,000 dollars into bet? **Mr. Hancock** answered yes. Commissioner Patterson asked staff for clarity on the current rule. AD Griffin replied by stating the petitioner is proposing to eliminate those subsections limiting the number of wagers per betting round and striking the single wager limits so it would be applicable to all poker games played in the state not just to No Limit Texas Hold'em. AD Griffin offered that as she understands it, the Commission would not be prohibited from narrowing the scope of the rule to allow the proposed changes. Commissioner Troyer stated the current betting limit is \$300 and asked Assistant Attorney General Matt Kernutt to add comment. Assistant Attorney General Matt Kernutt replied that this could very well be viewed as an expansion of gambling. AD **Griffin** explained this rule applies to all poker games, but it would be up to the Commission to change the scope of that. All Washington authorized gambling activities are to be limited in nature and scope by RCW 9.46.010 and have wagering limits. Staff recommends denial of the petition.

**Public Comment:** There was no public comment.

Commissioner Patterson explained that this Commission reviewed these same rules about two years ago and increased the limits from \$100 to \$300, and those new limits became effective by the end of 2016. She expressed concern about the discussion that took place and that this could be viewed as an expansion of gambling by the state legislature. She added that the Gambling Commission has been directed by the state legislature to limit the nature and the scope of gambling activities, and this request doesn't fit in with that direction. She also stated that all other gambling activities do have limits.

Commissioner Patterson suggested that this request be denied.

Commissioner Patterson move to deny the petition to change WAC 230-15-135. Commissioner Troyer seconded the Motion.
The Motion passed. 3:0

**Commissioner Troyer** said he is willing to look at this petition in the future with changes and more consideration.

## **Staff Request for Rule Change/Fee Simplification (Package #3)**

**AD Griffin** presented the materials for Tab 4. This package sets out the individual license fees under the new fee structure. Staff anticipates asking for an effective date of May 1, 2018, so that licensees who are renewing June 30, 2018 will pay their fees under the new system. The Rule Changes/Fee Simplification Package #3 will likely be up for final action at the March Commission Meeting.

**Public Comment:** There was no public comment.

## **Staff Request for Rule Changes/Fee Simplification (Package #4)**

**AD Griffin** presented the materials for Tab 5. This is the fourth Rule Changes/Fee Simplification package staff will bring forward to make changes to the Commission's licensing fee structure. This package clarifies that annual activity report filers will report their gambling activity for their license year through June 30, 2018 on July 30, 2018. All licensees will begin reporting their activity quarterly beginning with the July 1-September 30 quarter. The Rule Changes/Fee Simplification Package #4 will likely be up for final action at the March Commission Meeting.

**Public Comment:** There was no public comment.

## Other Business/General Discussion/Public Comment

Chair Sizemore announced that he has a conflict with the May 10, 2018 meeting date. He is asking to reschedule that meeting date to June 7. Commissioners are to get back to Julie Anderson with their approval of moving the meeting date as soon as possible. The June 7, 2018 meeting date would serve two purposes and that would be to have a Tribal Consultation meeting on the same day as the Commission Meeting. He adjourned the regular meeting at 11:15 to go into Executive Session to discuss Tribal Negotiations, Pending Investigations and Litigation. Executive Session is expected to adjourn at 12:15.

**Julie Anderson announced** at 12:15 that Executive Session would be extended 30 minutes.

The Commission meeting adjourned at 12:45.

SUBJECT: LEGISLATIVE UPDATE

The Legislature's cutoff for policy bills from the opposite house was March 2, 2018. The Legislature will adjourn on March 8, 2018. Below is a summary of noteworthy bills we are tracking and their current status.

#### **Bills Commissioners Voted to Support:**

#### 1. EHB 2332, Concerning Gambling Addiction

HB 2332, creating a self-exclusion program, was passed the Senate Labor and Commerce on February 19, 2018. It was sent to Rules and passed out of Rules to the Senate floor on February 28, 2018. The Senate did not vote on this bill by the March 2<sup>nd</sup> cutoff and it will not be passed into law this year.

#### **Problem Gambling Legislative Work Session (PowerPoint Attached):**

2. We had a very successful problem gambling work session in the House Commerce and Gaming Committee on February 19, 2018. Chair Leonard Forsman for the Suquamish Tribe and Washington Indian Gaming Association; Dr. Ty Lostutter, Assistant Director, University of Washington Psychology Internship Program and Board President, Evergreen Council on Problem Gambling; Maureen Greeley, Executive Director, Evergreen Council on Problem Gambling; Ann Gray, Problem Gambling Program Manager, DSHS; Dr. Charles Maurer, Board Member Emeritus, Evergreen Council on Problem Gambling; Donna Whitmire, Clinician, A Renewal Center; and Susan Harris Assistant Administrator/Clinician, Free by the Sea Residential Treatment Center were panelists that presented to the Committee. They did a wonderful job in presenting the Committee with helpful information on how problem gambling impacts people in our state and policy areas the Legislature should address moving forward.

Commissioner Patterson, Commissioner Stearns, and Director Trujillo also participated and provided helpful background to set up the panel discussions. Commissioner Patterson

also asked the Committee to work to pass the HB 2332; fund a problem gambling study in 2018; and create a problem gambling taskforce in 2019. The taskforce would possibly look at the state's current approach to data gathering, funding, education/prevention, and treatment to develop a comprehensive strategic plan and recommendations to the Legislature in 2020 or 2021.

Lastly, I would like to recognize Ann Gray in sharing her personal story with the Committee. Her story was an important tool to personalize this issue for the Committee and her story highlighted how someone with a gambling problem or disorder can persevere when they have access to necessary treatment and support.

#### **Bills with Direct Gambling Impacts:**

### 3. <u>HB 2881, Creating a new crime applicable to platforms, including internet web sites, that facilitate unauthorized gambling activity</u>

HB 2881 criminalizes the operation of an online website or platform that facilitates, or is used to facilitate, an unauthorized gambling activity. The Public Safety Committee held a hearing on January 30<sup>th</sup>, but the bill did not make it out of the Committee.

#### 4. SB 6266, Concerning loot boxes in online games and apps

SB 6266 identifies the use of video game "loot boxes" as a topic the Commission should investigate and determine if it is gambling. The Labor and Commerce Committee held a hearing on January 31<sup>st</sup> and passed the bill out of Committee to Senate Rules on February 1<sup>st</sup>. The bill did not make it out of Rules by the March 2<sup>nd</sup> deadline.

#### **Law Enforcement Bills**

#### 5. SHB 2718, Concerning seizure and forfeiture procedures and reporting

HB 2718 addresses civil forfeiture standards and reporting. The bill's new reporting requirements is the only section that impacts the agency. The bill passed out of the House on February 13<sup>th</sup> 95-3. It then was passed out of the Senate Law and Justice and Ways and Means Committees. The bill did not make it out of Rules by the March 2<sup>nd</sup> deadline.

### 6. <u>Initiative Measure Number 940 (I-940)</u>, <u>Police Training and Criminal Liability in Cases of Deadly Force Measure and HB 3003</u>, <u>Relating to Law Enforcement</u>

Legislators and stakeholders appear to have reached an agreement on I-940, and Representatives Goodman and Hayes's SHB 3003 is the compromise on I-940. The bill is supported by most stakeholders, including WASPC. The most relevant parts to our agents are: (1) The deadly force standard is changed to a better "objective reasonable officer standard;" (2) Training and first aid requirements are amended to provide more reasonable standards in these areas; (3) the notification requirement for a tribal member's death is streamlined to provide that an agency must notify the Governor's Office on Indian Affairs within at least 24-hours after a tribal member has died as a result of law enforcement use of deadly force; and (4) new requirement for the State to reimburse a law enforcement officer for reasonable costs of her or his defense when the officer is

charged and found not guilty or charges dismissed by reason of justifiable homicide or use of deadly force, or by reason of self-defense.

As you may remember, I-940 cannot be amended by the Legislature and can only be passed as it is written. If it is not passed in whole, then it is to go to the November 2018 general election ballot. Therefore, the legislative plan is for the Legislature to pass I-940 by Thursday, March 8<sup>th</sup> and then also pass HB 3003 as a "trailer bill." This would effectively amend I-940 with the above changes once it becomes law. If successful, this plan would implement the compromise without requiring the initiative language to be on the November 2018 general election ballot.

#### **Budget and Other Bills Impacting the Agency**

### 7. <u>HB 2299/SB 6032, supplemental operating appropriations – Problem Gambling Study (attached)</u>

Both the House and Senate supplemental operating budgets contain an appropriation for a problem gambling study. The Senate appropriates \$50,000 from the general fund for a problem gambling study. The House attempts to appropriate \$100,000 from the gambling revolving account for a problem gambling study. I have been working with our ex officio members, stakeholders, and the budget writers on new language to reconcile the two different approaches.

I have attached the proposed amended language sent to the budget writers on March 2, 2018. We are asking for a \$100,000 general fund appropriation and a \$50,000 Lottery fund appropriation for a problem gambling study. These funds could only be used if the Commission secured a matching \$150,000 in funding that it provides or a combination of funds from the gambling revolving account and outside funds from governmental or private organizations.

#### 8. HB 2611, Concerning the privilege for peer support group counselors

Representative Barkis' HB 2611 establishes a testimonial privilege for certain communications made by a limited authority law enforcement officer to a peer support group counselor while receiving counseling. This bill provides helpful clarification for the agency in its use of peer support groups when a critical incident occurs. This bill was passed out of the House on February 13<sup>th</sup> 98-0 and the Senate passed it on February 28<sup>th</sup> 49-0. It is expected to go to the Governor's office for signature on or before March 8<sup>th</sup>.

#### **Commissioner Confirmations**

**9.** Commissioner Sizemore and Commissioner Patterson are now confirmed. Due to the backlog of confirmations, we will have to wait until the 2019 Legislative Session before Commissioner Steams and Commissioner Troyer can be confirmed.



# It's Time to Take a Fresh Look at Problem Gambling


### Rate of Problem Gambling: 1990s

- ➤ In WA State, approximately 1% of the total sample of adolescent respondents were classified as problem gamblers. Another 8% of the total sample of adolescent respondents were classified as gamblers at risk for developing gambling problems.
- ➤ WA State residents aged 18 and over, it was estimated that 5-6% classified as lifetime problem gamblers. An additional 1-2% classified as lifetime probable pathological gamblers. The study when on to state that between 1-3% were classified as current problem gamblers. And additional 1% could be classified as current probable pathological gamblers.



- ➤ Social Costs Calculated based on National Gambling Impact Study Commission estimates that each problem gambler costs society a total \$1,915.
- ➤ Washington is 26th out of 40 states that provide public funding for problem gambling services. The average per capita in funding is approximately \$0.37 and WA is at about \$0.10.
- ➤ Additional research shows \$1 spent in problem gambling services saves \$2 in social costs.







#### Describe the Rule Changes

This is the fifth rules package staff will bring forward to make changes to the Commission's licensing fee structure. The fifth rules package covers the following:

- Licensees must report their gross gambling receipts on their quarterly license reports and submit a quarterly license report for each quarter they hold a license even if they have paid their annual maximum license fee.
- Add a fee for Linked Bingo Prize Providers oversight by not originally including it in the fee schedule in package #1.

#### **Policy Considerations**

The Commissioners began considering changing the fee structure in 2014. The current fee structure was created over 40 years ago. It began with 25 fees. Today the Gambling Commission has approximately 194 different fees for Commercial and Non-Profit organizations and individuals. This fee schedule is typically based on a "class" system, which can be cumbersome for licensees and agency staff. The Gambling Commission is looking to simplify this current system to allow it to be easier to navigate and have a licensing fee schedule that is more predictable for both the agency and its licensees.

#### Staff Recommendation

Staff recommends filing for further discussion. Staff anticipates asking for an effective date of July 1, 2018.

Mr. McNutt requested a rule change to allow for pre-shuffled cards to be used in the card game minibaccarat. Staff requested additional rule changes to ensure the integrity of the pre-shuffled card manufacturing process. Staff reviewed pre-shuffled card regulations from 16 U.S. or Canadian jurisdictions and worked with stakeholders since May 2017, including:

- June 8, 2017: Notice of Rule Making sent to HBCR and Manufacturer licensees;
- July 12, 2017: Stakeholder Meeting at Lacey office with call-in feature. 19 people participated in the meeting and card manufacturers agreed to submit information to facilitate writing rules and internal controls;
- Oct 2017-January 2018: Completed fee simplification rules;
- Jan. 29, 2018: Notice sent to stakeholder workgroup with draft rules and internal controls; and
- Feb 8, 2018: Stakeholder meeting at Lacey office with call-in feature. 9 people participated in the meeting and all agreed with staff proposed rule changes.

#### Proposed Rule Change

Staff and stakeholders have agreed upon the following amended and new rules:

- Approval of pre-shuffled cards to be used in mini-baccarat;
- New approval process for pre-shuffled card manufacturers only; and
- New process for the manufacturing of pre-shuffled cards, including approval of shuffling device used to pre-shuffle cards; inspection and verification methods; and quality control standards.

#### WAC 230-15-115 Standards for cards. (1) Card game licensees must:

- (a) Supply cards of conventional size and design to maximize the integrity of the card games; and
  - (b) Safequard all cards; and

  - (2) For Class E, Class F, and house-banked games, the cards must:
  - (a) Be made by a licensed manufacturer; and

- (4) Pre-shuffled cards, as approved by the director or the director's designee, can be used for mini-baccarat and approved proprietary variations of mini-baccarat in accordance with approved internal controls.

#### WAC 230-06-053 Approval to provide pre-shuffled cards.

- (1) Licensed manufacturers must obtain approval by the director or director's designee prior to selling pre-shuffled cards in Washington.
- (2) Manufacturers must ensure quality control of the pre-shuffled cards to protect players or licensees. To obtain approval, manufacturers must submit in writing to us the following for our review:
  - (a) An overview of the product;
  - (b) Site security provided at the facility;
  - (c) Procedures utilized to ensure the pre-shuffled process;
  - (d) Procedures utilized to ensure randomness;
  - (e) Procedures to detect irregularities;
  - (f) A deposit to cover the cost of our review, which may include an on-site review to verify the above; and
  - (g) Identify the automated shuffling device used to pre-shuffle cards.
- (3) Manufacturers must comply with all rules regarding pre-shuffled cards.
- (4) If you do not agree with the director or director's designee's decision, you may file a petition for declaratory order with the commission according to RCW 34.05.240 and chapter 230-17 WAC.

#### WAC 230-16-158 Pre-shuffled cards.

Manufacturers of pre-shuffled cards must:

- (1) Obtain approval from the director or director's designee for the automated shuffling device used to pre-shuffle cards; and
- (2) Implement a process for producing, shuffling and packaging pre-shuffled cards which will, at a minimum, include:
  - (a) Visual inspection of the back of each card to assure that it is not flawed, scratched or marked in any way that might compromise the integrity or fairness of the game;
  - (b) Verification that each package of cards contains the correct number of suits and is constituted in accordance with the specific rules of the game the cards are intended for use;
  - (c) Inserting the cards in a package with a tamper-proof package seal(s) that bears the conspicuous indication if the package has been opened. The exterior of the package will indicate:
    - (1) The total number of decks contained within the package; and
    - (2) The game(s) the cards are intended for use; and
    - (3) The color of the pre-shuffled cards.
  - (d) Generation of a receipt to be inserted in the sealed package or a label on the sealed package, which shall include the following information:
    - (1) The total number of cards and decks contained within the package. If using an exterior label, this information will suffice for (2)(c)(1) above;
    - (2) The date and time the pre-shuffled cards were shuffled, packaged and verified;
    - (3) Identification of the manufacturer's employee who shuffled, packaged and verified the cards; and
    - (4) The manufacturer, model and serial number of the production line or device used to shuffle the cards.

On May 12, 2017, the Commissioners voted to initiate rulemaking with the understanding that staff would work with the petitioner and stakeholders to develop the:

- Rule(s) needed to allow pre-shuffled cards to be used for playing Baccarat;
- Rule(s) outlining the quality control standards card manufacturers would need to follow;
- Process staff would take to verify the integrity of the manufacturing process of pre-shuffled cards, which would include such things as documenting the manufacturer's procedures to ensure pre-shuffled decks are complete, free of markings, and are in a random order; and
- Internal controls a house-banked card room would be required to have prior to using preshuffled cards.

Our next step is to meet with stakeholders to discuss and then develop the above items. #### Who Proposed the Rule Change?

Stacy Hess, Great American Gambling Corporation, Tukwila, WA.

#### Petition for Rule-making Request

Petitioner requests a rule change to the Commission's soft count rules to allow:

- Two people to conduct a soft count if the licensee uses an automated bill counter.
- Automated bill counter rules would require the automated bill counter to have at least:
  - o A full-color, touch-screen display which allows operators to change pocket configurations and switch operating modes easily.
  - o This screen must be visible from Surveillance for the full duration of the count;
  - o Ability to provide a printout of total bill and dollar amounts counted per drop box;
  - o Ability to provide a printout of total bill and dollar amounts counted for the complete drop.
- Revised counting procedures when using the automated bill counter.

The Petitioner states these rule changes are needed to provide for better soft count accuracy and accountability. It will also be more cost effective for licensed card rooms. The petitioner submitted proposed rule language and a brochure for an automated bill counter machine.

#### Licensees Impacted

The proposed change would impact all house-banked card room licensees. As of March 1, 2018, there are 47 house-banked licensed card rooms.

#### **Staff Recommendation**

Staff recommends accepting the petition and initiating rule-making as requested by the Petitioner. The Commission must vote on this petition within 60 days of receiving it and you have the following options under the Administrative Procedure Act:

- 1) Initiate rule-making proceedings. Staff would then work with the petitioner and stakeholders on language to amend any necessary soft count rules and bring amended rules to you to file for further discussion, which would also require a vote; or
- 2) Deny the petition in writing, stating the reasons for the denial and specifically address the concerns stated in the petition. If appropriate, the Commission can indicate alternative means by which the agency will address the concerns raised in the petition.

#### WAC 230-15-610

#### Preparing to conduct a count.

- (1)\* House-banked card game licensees must assign employees to conduct the count. The count team must be made up of three or more licensed employees. The count team must not include anyone who works in the surveillance department or whose duties included preparing, approving, or reviewing records used in that specific count process.
- (2) Licensees must accurately count and record the contents of drop boxes to ensure the proper accountability of all gambling chips, coin, and currency. The count must be done at least once each gambling day.
- (3) If a cage cashier completes the opener, closer, fills, and credits portions of the master game report, the cashier sends the original master game report to the count team for completion. The cage cashier must immediately send a copy directly to the accounting department.
- (4) A count team member must notify the surveillance room observer that the count is about to begin. The surveillance employee must then make a video and audio recording of the entire count process.
- (5) Before opening drop boxes, the count team must lock the door to the count room. Licensees must permit no person to enter or leave the count room, except for a normal work break or an emergency, until the count team has completed the entire counting, recording, and verification process for the contents of drop boxes.

#### Revision:

- \*(1) House-banked card game licensees must assign employees to conduct the count. The count team must be made up of three or more licensed employees or where an automated bill-counter is used, the count team must be made up of **two** or more licensed employees. #### Conducting the count.

- (1) The contents of drop boxes must not be combined before the count team separately counts and records the contents of each box; and

- (3) A count team member must empty the contents onto the count table; and
- (4) Immediately after the contents are emptied onto the count table, a count team member must display the inside of the drop box to the closed circuit television camera, and show it to at least one other count team member to confirm that all contents of the drop box have been removed. A count team member must then lock the drop box and place it in the drop box storage area; and
- (5)\* Count team member(s) must separate the contents of each drop box into separate stacks on the count table by denominations of coin, chips, and currency and by type of form, record, or document;

If an approved currency counting machine is being used,

\*(5) Count team member(s) must combine the contents of each drop box into **one** stack on the count table, in preparation of being loaded into the automated bill-counter. Coins and chips will be separated on the count table by denomination.

Otherwise, the count team must complete all required information on the master game report; and



#### Who Proposed the Rule Change?

Dennis Korthouwer, Hit Utopia, Inc., Franeker, Netherlands.

#### Describe the Petitioner's Request

The Petitioner requests a rule change to the Commission's gambling promotion rules in WAC 230-06-030. The petitioner did not submit proposed rule language. Instead, the petitioner requests that the promotion rule be amended to authorize licensed card rooms to give promotional prizes or items using an electronic device that contains a random number generator.

The Petitioner states the following: "Manual draws make that only very limited - often more costly - prizes can be offered. Hit Utopia developed an automated draw process in which a certified random number generator picks the winner of the promotional prize. This is not only more secure, the draw can also be done very often (like with every game) with very small prizes. The effect of this rule change will be: That more and more diverse promotional prizes can be awarded to players in a more secure way."

#### Background

The Commission amended its promotion rules based on a rules petition we received in 2016 from the Recreational Gaming Association. In relevant part, the adopted rules authorized operators to offer gambling promotions that allow entry based on disclosed criteria; offer lottery tickets as a prize; add additional merchandise or cash prizes to licensed gambling activities; and allow card rooms to use a physical drawing, spinning a wheel or selection from a group of concealed items to award a prize. These rule changes went into effect on February 19, 2017.

#### Licensees Impacted

The proposed change would impact all Class E, F and house-banked card room licensees. As of March 1, 2018, there are 47 house-banked, 3 Class F, and 6 Class E licensed card rooms.

#### **Staff Recommendation**

Staff recommends denial of the petition. Staff believes this is a gambling activity and gambling device and should not be coupled with a gambling promotion.

The Commission must vote on this petition within 60 days of receiving it and you have the following options under the Administrative Procedure Act:

- 1) Initiate rule-making proceedings. Staff would then work with the petitioner and stakeholders on language to remove the above-referenced rules and bring amended rules to you to file for further discussion, which would also require a vote; or
- 2) Deny the petition in writing, stating the reasons for the denial and specifically address the concerns stated in the petition. If appropriate, the Commission must indicate alternative means by which the agency will address the concerns raised in the petition.

This is the third of five packages staff will bring forward to make changes to the Commission's licensing fee structure. This third package sets the individual license fees under the new license fee structure. The key changes to individual license fees in this third package:

If a distributor, linked bingo prize provider or service supplier leaves their employer and goes to another employer during their license year, they have to reapply and pay the renewal fee of \$167. By adding a fee and rule language to allow these representatives to change employers, these representative will save \$102 if they change employers during their license year.

**NOTE 2:** Currently, manufacturer representatives can represent more than one manufacturer but they do not pay a fee when adding or changing employers (WAC 230-03-330(2) and (3)). When they pack a set or collation of cards in more than one shipping container, manufacturers may attach the I.D. stamp to the first container and print the I.D. stamp number on all remaining shipping containers.
- (2) Electronic pull-tab dispensers, electronic bingo card daubers, and electronic facsimile card tables Manufacturers or owners must attach I.D. stamps on the outside of the main body, in an area that is not normally removed and replaced, and in a way that does not obstruct the view of the pull-tabs available for play, the bingo cards, or the card facsimiles.
- (3) Electromechanical and mechanical pull-tab dispensers Manufacturers or owners must attach I.D. stamps on the outside of the main body, in an area that is not normally removed and replaced, and in a way that does not obstruct the view of the pull-tabs available for play or the card facsimiles. Licensees may discard records entry labels.
- (4) Amusement games Owners must attach I.D. stamps on the outside of the main body, in an area that is not normally removed and replaced, and in a way that does not obstruct the view of the amusement game prizes.))

- WAC 230-16-180 Record retention for I.D. stamp records. Manufacturers must keep records that provide an accountability trail for all I.D. stamps ((purchased)).

#### Background:

Our rules require licensees to get your approval prior to offering raffle prizes that exceed \$300,000 in a license year, WAC 230-11-067.

To seek that approval, the licensee must submit a raffle plan that includes:

- (a) The organization's goals for conducting raffles; and
- (b) A brief overview of the licensee's mission and vision including the type of programs supported by the licensee and clients served; and
- (c) Plans for selling raffle tickets; and
- (d) Brief overview of prizes awarded; and
- (e) Estimated gross gambling receipts, expenses, and net income for the raffles; and
- (f) Any other information that we request or any information the licensee wishes to submit.

At your July 13, 2017, meeting, the Rocky Mountain Elk Foundation (RMEF), Inc. asked for approval to exceed the raffle prize limit for their license year that ended on February 27, 2018. You approved RMEF to offer raffle prizes up to \$400,000 You also told them they needed to come back at the beginning of their license year in 2018 to get approval for their next year. This is why they are coming before the Commission now.

#### Request for Your Approval:

For their new license year (which will end December 31, 2018, as they transition into the new fee structure), the Rocky Mountain Elk Foundation, Inc. is seeking your approval to offer raffle

prizes over \$300,000 or, if the Commission seeks to set a raffle prize limit as you did last year, to \$400,000

Staff recommends you approve the Rocky Mountain Elk Foundation, Inc. to exceed the annual raffle prize limit of \$300,000 for their license year ending December 31, 2018.

# Requesting commission approval prior to offering raffle prizes exceeding forty thousand dollars per prize or three hundred thousand dollars in a license year.

- (1) The commissioners may vote to approve a licensee to exceed raffle prize limits if a licensee shows good cause in writing.
- (2) Prior to offering raffle prizes that exceed forty thousand dollars per prize, the licensee must submit a raffle plan to us that includes at least the following information:
  - (a) The organization's goals for conducting the raffle; and
- (b) A brief overview of the licensee's mission and vision including the type of programs supported by the licensee and clients served; and
  - (c) Specific details of the raffle rules including:
  - (i) Date of the drawing; and
  - (ii) Cost of raffle tickets; and
  - (iii) Prizes available; and
  - (iv) Security of prizes; and
  - (v) Plans for selling raffle tickets; and
  - (vi) Description of how the licensee protects the integrity of the raffle; and
  - (d) An explanation of how the proceeds from the raffle will be used; and
  - (e) A plan to protect the licensee in the event of low ticket sales and other risks; and
  - (f) An explanation of how the licensee will purchase the prize(s) for the raffle; and
  - (g) A projected budget including:
  - (i) Estimated gross gambling receipts, expenses, and net income for the raffle; and
  - (ii) Minimum number of projected ticket sales to break even; and
- (iii) Corresponding sales and prize levels with projected revenues and expenses for each level; and
  - (iv) Minimum and maximum prizes available; and
  - (h) Any other information that we request or any information the licensee wishes to submit.
- (3) Prior to offering raffle prizes that exceed three hundred thousand dollars in a license year, the licensee must submit a raffle plan that includes:
  - (a) The organization's goals for conducting raffles; and
- (b) A brief overview of the licensee's mission and vision including the type of programs supported by the licensee and clients served; and
  - (c) Plans for selling raffle tickets; and
  - (d) Brief overview of prizes awarded; and
  - (e) Estimated gross gambling receipts, expenses, and net income for the raffles; and

#### • (1) The organization's goals for conducting raffles

The Rocky Mountain Elk Foundation conducts raffles in the state of Washington to raise funds to support our mission. Raffles are an important facet of RMEF's diverse fundraising efforts, which include auctions, membership and dues sales, merchandising, and charitable solicitation. RMEF's goal is to continue fundraising efforts in the state of Washington in order to support additional land protection, public access and habitat enhancement projects.

# • (2) A brief overview of the licensee's mission and vision including the type of programs supported by the licensee and clients served

The mission of the Rocky Mountain Elk Foundation is to ensure the future of elk, other wildlife, their habitat and our hunting heritage.

In support of our mission, the RMEF is committed to: conserving, restoring and enhancing natural habitats; promoting the sound management of wild elk, which may be hunted or otherwise enjoyed; restoring elk to their native ranges; and educating members and the public about habitat conservation and our hunting heritage

The statistics above give a succinct picture of what RMEF accomplishes nationwide with support from members, volunteers along with local, state and federal agencies. However, it would be remiss of RMEF to not show the commission what we are able to do in Washington with that same support particularly from Washington-based members, volunteers, and support from local and state agencies.

### ROCKY MOUNTAIN ELK FOUNDATION



In the last two years, RMEF has put over \$1.4 million dollars on the ground to benefit the people of the State of Washington. Everything from funding youth days for kids to get in the outdoors, to helping fund a poaching information reward for the WDFW, to reinvigorating elk and other animal habitats through planting native flora and working on removal of invasive flora species. RMEF has used money raised by raffles in Washington, to take on even larger projects such as funding a study of elk and related habitat enhancement on the Upper Snoqualmie Valley.

A prime example of using gaming funding for public benefit in Washington was the purchase of the Merrill Lake property. RMEF, in partnership with WDFW and other private and public organizations, purchased the former timberland property, permanently protecting and providing public access to 1,453 acres of critical riparian habitat at the foot of Mount St. Helens. RMEF has conveyed the majority of the acreage to WDFW for public ownership and management, and plans to convey the remainder within the next several years.

This is not the only large-scale Washington project that RMEF is working on with state agency partners. In addition to Merrill Lake, RMEF has purchased and is currently holding the Tucannon property which RMEF will convey to WDFW when the agency has the funding and preparation to take possession of the property and manage it. In the past, RMEF has also worked to convey property the US Forest Service, in order to provide better public access to existing public lands and protect vital wildlife habitat.

Large-scale projects that benefit all the people of Washington are only possible with help from gaming funds raised in Washington being leveraged with other fund-raising and major private gifts to RMEF.

It is also important to remember that each year a committee made up of Washington RMEF volunteers and representation from RMEF HQ decide, based on proposals, of how to spend funds specifically earmarked to be used in Washington each year. In fact this year that committee will have \$346,000 to use in benefiting the people, animals, and habitat in Washington. Some examples of past proposals founded are below.

- Projects that educate members and the public about habitat conservation, the value of hunting, hunting ethics, and/or wildlife management.
- Scholarships to natural history or outdoor skills programs, such as Becoming an Outdoors-Woman.
- Membership in or sponsorship of state-based organizations associated with the National Assembly of Sportsmen's Caucuses.
- Outdoor skills programs including shooting, survival, and hunting skills programs.
- Teaching tools for youth educators (e.g., elk and wildlife trunks).
- Marketing tools and activities directly related to the support and promotion of RMEF's
  mission including exhibits, booths, displays, public relations, promotional materials and
  sponsorship.



#### • (3) Plans for selling raffle tickets

RMEF chapters in Washington sell raffle tickets in face to face transactions by volunteers throughout the state. Each chapter typically conducts numerous raffles which are drawn at an annual event, called the Big Game Banquet, as well as other smaller events and raffles that may occur from time to time. RMEF will also sell raffle tickets at various businesses in each chapter's area, at Big Game Banquets and at other events. Advertising for chapter events will take place via email, on RMEF's website, through RMEF's bi-monthly magazine, Bugle, and through a variety of local publications and signage.

#### • (4) Brief overview of prizes awarded

Various merchandise including firearms, sporting goods, equipment, home goods, gift certificates, hunting and fishing trips.

#### • (5) Estimated gross gambling receipts, expenses, and net income for the raffles

Estimated gross gambling receipts: \$ 740,000.00

Estimated gross expenses: \$ 330,000

Estimated net income (Gross gambling receipts less prizes paid): \$410,000.00

## • (6) Any other information that we request or any information the licensee wishes to submit.

Rocky Mountain Elk Foundation legal staff and Regional Directors continue to meet with chapter chairs, state chairs, and volunteers in order to provide training on the importance of complying with Washington charitable gaming laws, record keeping requirements and the conduct of charitable raffles. RMEF staff and volunteers remain committed to conducting raffles in Washington, in a lawful and transparent manner.

RMEF is providing this raffle plan in order to better inform the Washington Gambling Commission of RMEF's raffle activities and charitable works in the state. RMEF requests that the Commission grant RMEF permission to exceed the \$300,000 raffle prize limit for the 2018-2019 license year. If the Commission determines that a new prize limit is advisable, RMEF suggests a limit of \$400,000 for the 2018-2019 license year. RMEF is grateful to the Committee for their time and effort in considering this petition.
