Thank you for requesting approval to market the card game "Bad Beat Baccarat – Upgrade" to Washington State commercial card rooms and Tribal casinos. Based on our review of the documentation we received from Aces Up Gaming, Inc, the Washington State Gambling Commission will approve the game under the conditions listed below:

The game shall be played and operated under the terms and conditions set forth under the "Bad Beat Baccarat" rules of play you provided and are enclosed.

Commercial Card Rooms

- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

Tribal Casinos

- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.
- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.



Bad Beat Baccarat

Rules of Play

Bad Beat Baccarat is a standard Mini-Baccarat game but with additional bonus wagers and is played using six or eight standard decks of 52 cards. Bad Beat Baccarat may be offered with either the Classic or Infinite Fortune themes and these themes may offer only the bonus wagers as noted in the rules of play. Bad Beat Baccarat may be offered either as a Commission or No Commission game.

- All rules pertaining to Mini-Baccarat as posted on the WSGC's public website remain the same and are not altered in this game.
- To begin, each player may place the base game wagers and additionally place a bonus wager on the Bad Beat Baccarat, Super Shot Bad Beat, Super Shot Tie, Banker/Super 7, Player/Fortune 8 or the Player Pair/Banker Pair bonus wagers. (Licensee discretion to make base game Mini Baccarat wager mandatory.)
- **Wagering limits cannot exceed the authorized limits set out in WAC-230-15-040 and 230-15-140.**
 - Side bets among players is prohibited.
- Once all bonus wagers are placed, the game is dealt following standard Mini Baccarat rules and procedures as approved and posted on WSGC's website. Note: For no-commission mini baccarat games, if the Banker hand totals 7 with three cards and is higher than the Player hand, all Banker wagers push.
- After the Mini Baccarat hand is completed, all bonus wagers are resolved as follows:



Bonus Wagers

The Bonus Wagers allows players to spread their wagers between multiple outcomes. Each of these outcomes is considered a different game.

Bad Beat Baccarat Bonus Wager

The player has the option to place a bet on the Bad Beat Baccarat Bonus wager and will win when one of the hands (Player or Banker) wins with exactly one point over the other hand.

3 Card 9 over 3 Card 8	40 to 1
Natural 9 over 8	10 to 1
Any 8 over 7	6 to 1
Any 7 over 6	4 to 1
Any Lose by 1	1 to 1

Super Shot Bad Beat Bonus Wager

There are three individual bonus wagers with each winning on specific outcomes. The hand values are interchangeable between the Player and the Banker hands

3 Card 9 over 3 Card 8	200 to 1
Natural 9 over Natural 8 (Option 1)	50 to 1
(Option 2)	45 to 1
(Option 3)	40 to 1
Any 8 over Any 7	25 to 1



Super Shot Tie Bonus Wager

There are two individual bonus wagers with each winning on specific outcomes that tie.

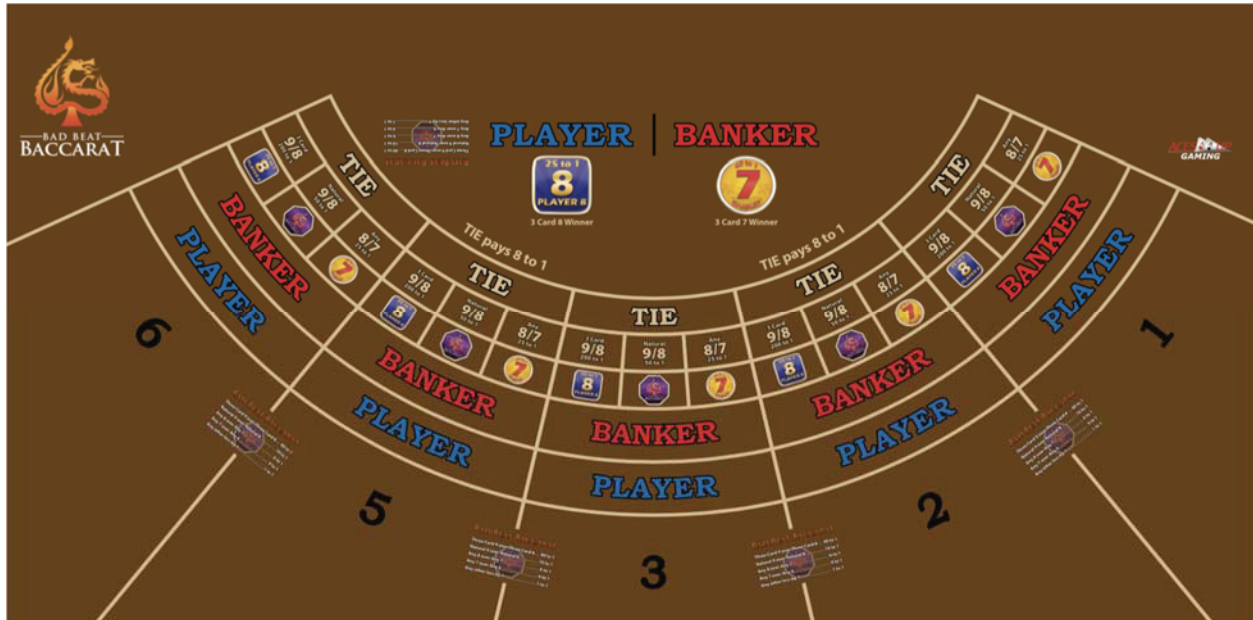
6 over 6	40 to 1
7 over 7	40 to 1

- The Bank/Super 7 bonus wager pays 40 to 1 when the Banker wins with a three-card hand totaling 7.
- The Player/Fortune 8 bonus wager pays 25 to 1 when the Player wins with a three-card hand totaling 8.

Banker Pair and Player Pair

- The Banker Pair bonus wager pays 11 to 1 when the first two cards of the Banker are a pair.
- The Player Pair bonus wager pays 11 to 1 when the first two cards of the Player are a pair.

Banker Pair	11 to 1
Player Pair	11 to 1
