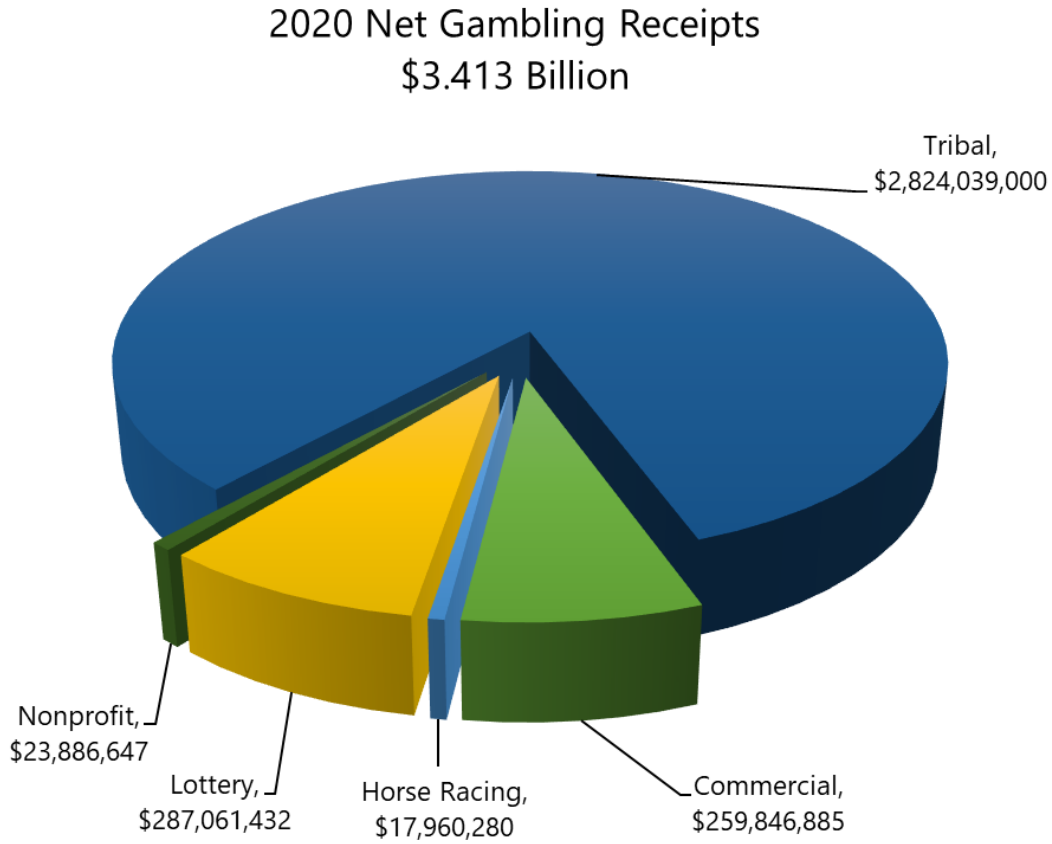

Washington's Gambling Industry

Washington's gambling industry is comprised of five categories: Commercial, Lottery, Horse racing, Nonprofit, and Tribal¹. In FY 20, the industry generated \$3.413 billion in net gambling receipts².



In FY 20, local jurisdictions collected \$29,331,984 in gambling taxes.

The following pages of this report are reflective of the gambling activities required to be reported under [WAC 230-05-112](#) and is not a complete list of all the activities regulated by the Gambling Commission.

¹ Non-Tribal net gambling receipts are reported by fiscal year (7/1/19 - 6/30/20). Tribal operators report net receipts by calendar year.

² Net receipts are equal to gross receipts minus prizes paid.
