Dear Ms. Green,

Thank you for requesting approval of the upgrade to the Deck Mate 2 Shuffler which was previously approved in August 2019. We have completed our review.

The Deck Mate 2 may be operated as a shuffler in Washington State. The approval is contingent on the following requirements:

Manufacturer Requirements:

- Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.
- When using a laptop or other specifically authorized external tool to connect to the shuffler ensure compliance with WAC 230-16-151.
- The QikTable and ShuffleLink features were not submitted or tested with the DM2 shuffler and are not authorized for use in WA.

Operator Requirements:

- Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.
- The QikTable and ShuffleLink features were not submitted or tested with the DM2 shuffler and are not authorized for use in WA.

Tribal Casino Implementation:

For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by Washington State Gambling Commission.
