Dear Mr. Michels:

Thank you for requesting approval of the Shark Trap Shuffler. We have completed our review.

The Shark Trap Shuffler is approved for use in Washington State. The approval is contingent on the following requirements.

Manufacturer Requirements:

- Ensure the shuffler can only be used for Blackjack and Spanish 21 style games that do not require the use of Jokers. The shuffler was not reviewed for the use of Novelty Games.
- Ensure that tape or a metal cover must be placed over the access point at the bottom of the shuffler to restrict access to the toggle switch that allows the shuffler to be switched from Blackjack to Novelty games.

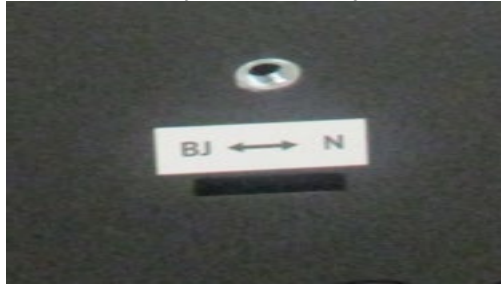

House-Banked Card Game Licensee Requirements:

- Ensure only approved card games, as posted on the WSGC website, are played.
- Shark Trap Shuffler must notify us prior to installation in Washington so arrangements may be made for Agent inspection/review to ensure that the software signature and firmware version of the shuffler be verified prior to being put into play since they cannot be verified during operation.

Tribal Casino Implementation:

- Ensure only approved card games, as posted on the WSGC website, are played.
- Ensure internal controls are revised to include new equipment and procedures.
- Ensure updated internal controls are approved by the Tribal Gaming Agency and concurred by the Washington State Gambling Commission.
- Shark Trap Shuffler must notify us prior to installation in Washington so arrangements may be made for Agent inspection/review to ensure that the software signature and firmware version of the shuffler be verified prior to being put into play since they cannot be verified during operation.


