Dear Ms. Zarach,

Thank you for requesting approval of the Light and Wonder i-Score Ultra Dragon Bonus v3.1.1. We have completed our review.

The Light and Wonder i-Score Ultra Dragon Bonus v3.1.1 is approved for use in Washington State. The approval is contingent on the following requirements.

House-Banked Card Game Licensee Requirements:

- The i-Score Ultra may be used independently or with approved equipment. If used with equipment, ensure only approved equipment is connected to the i-Score Ultra ShuffleStar Shuffler and Safe Shoe Baccarat 97700-XX, Safe Shoe Blackjack 997701-XX, Safe Shoe X DE118906, and Safe Shoe DE130393-XX.
- If connected to the ShuffleStar Shuffler, or Safe Shoe, ensure the keypad is only attached to the i-Score Ultra during configuration of the display.
- Ensure there is a user login and password set up on the PC table processor prior to startup to limit access by unauthorized users.

Tribal Casino Implementation:

- For Tribal Casinos, ensure internal controls and game rules are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by Washington State Gambling Commission.
- The i-Score Ultra may be used independently or with approved equipment. If used with equipment, ensure only approved equipment is connected to the i-Score Ultra ShuffleStar Shuffler and Safe Shoe Baccarat 97700-XX, Safe Shoe Blackjack 997701-XX, Safe Shoe X DE118906, and Safe Shoe DE130393-XX.
- If connected to the ShuffleStar Shuffler or approved Safe Shoe, we recommend the keypad is only attached to the i-Score Ultra during configuration of the display.
- We recommend there is a user login and password set up on the PC table processor prior to startup to limit access by unauthorized users.
