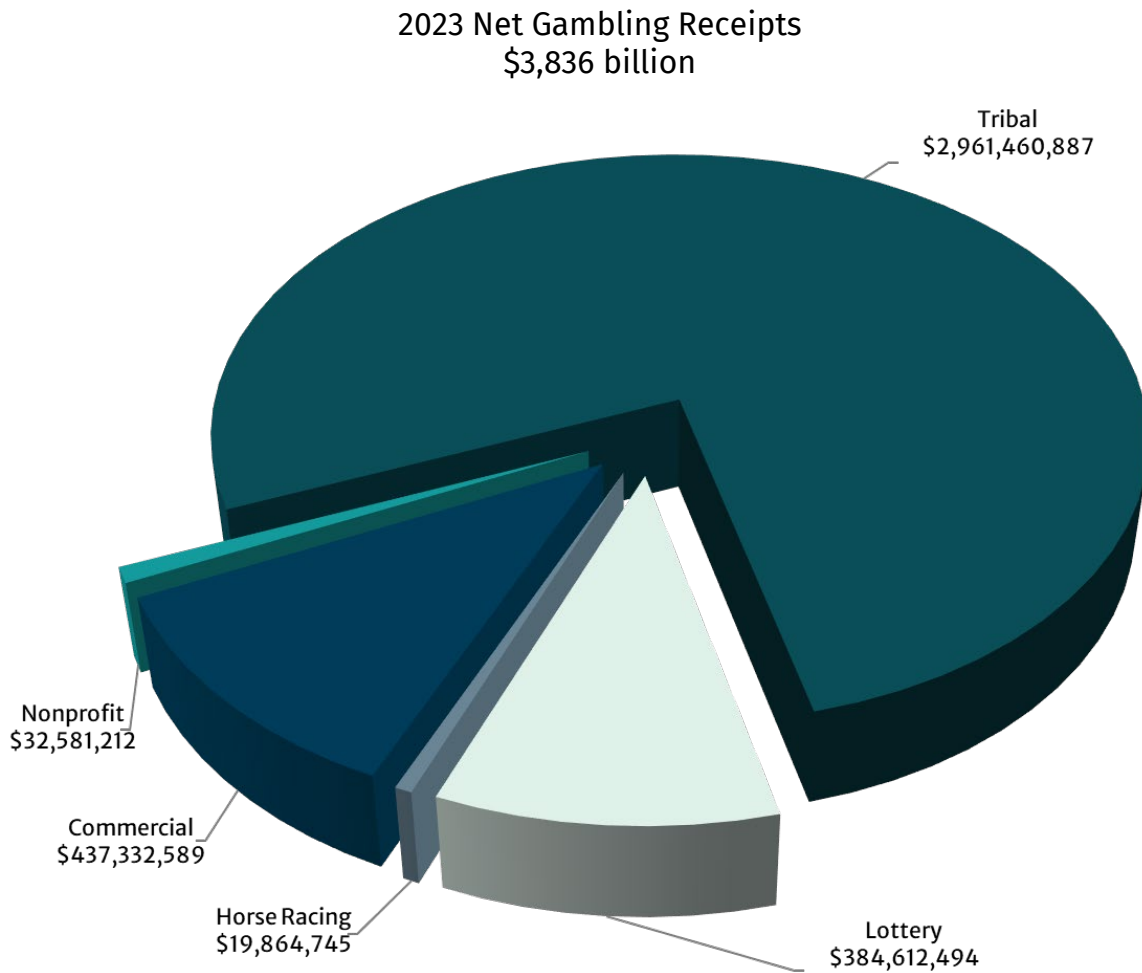

Washington's Gambling Industry

Washington's gambling industry is comprised of five categories: commercial, lottery, horse racing, nonprofit, and tribal¹. In fiscal year 23, the industry generated \$3.836 billion in net gambling receipts².



In FY 23, local jurisdictions collected \$39,450,510 in gambling taxes.

¹ Non-tribal net gambling receipts are reported by fiscal year (7/1/22 - 6/30/23). Tribal operators report net receipts by calendar year.

² Net receipts are equal to gross receipts minus prizes paid.
