Dear Ms. Kein,

Thank you for requesting approval of the upgrade to the Bump 50:50 Electronic Raffle System. We have completed our review.

The Bump 50:50 Electronic Raffle System is approved for use in Washington State. The approval is contingent on the following requirements.

Manufacturer Requirements:

- An onsite review must be completed at each venue prior to operation to ensure the Pax A800 complies with the communication requirements in WAC 230-11-310.
- Notify the WSGC of any changes made to the firewall configuration (in relation to the electronic raffle system network) or equipment prior to those changes taking place to identify if further testing or review is required.

<u>Requirements for Electronic Raffle Licensees:</u>

- An onsite review must be completed at your venue prior to operation to ensure the Pax A800 complies with the communication requirements in WAC 230-11-310.
- Ensure a unique PIN is added to the RSU's upon initial login in the event that one is lost or stolen.
- Notify the WSGC of any changes made to the firewall configuration (in relation to the electronic raffle system network) or equipment prior to those changes taking place to identify if further testing or review is required.
