RE: Submission #3191 Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero

Dear Ms. Abad,

Thank you for requesting approval of the Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero. We have completed our review. The Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero are approved for use in Washington State Tribal Casinos.

Approval of the Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero is contingent on the following requirements:

## Manufacturer Requirements:

- The upgraded Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero was tested and approved for use with the previously approved Ora Grande Display.
- Saturn Wheel is approved to be operated with single or double zero.
- The Wheelmate should not be connected to the wheel during live play.

• Ensure internal controls and game rules are revised to include new equipment, and procedures and are approved by the Tribal Gaming Agency and concurred with by the Washington State Gambling Commission.

Any modifications made to the Saturn Roulette Wheel (Starburst/Traditional) with optional GLO and Wheelmate option in Single Zero and Double Zero must be submitted to us for additional testing and review. We reserve the right to investigate and re-evaluate this equipment if we determine that such a review is necessary to ensure compliance with tribal state compacts or rules and laws of Washington.

Please notify Special Agent Julie Kerkof at <u>Julie.kerkof@wsgc.wa.gov</u> at least 2 weeks prior to any scheduled installation of the Saturn Roulette Wheel with optional Glo and Wheelmate into a tribal casino.
