Dear Ms. Zarach,

Thank you for requesting approval of the upgrade to the ShuffleStar Shuffler. We have completed our review.

The ShuffleStar Shuffler is approved for use in Washington State. The approval is contingent on the following requirements.

#### **Manufacturer Requirements:**

- Only iScore Ultra is allowed to be connected to the ShuffleStar Shuffler. iTable, Fusion Hybrid, Quartz Table Systems and Shuffle Flex were not submitted for review with this submission and must be disabled prior to installing the system in Washington.
- Ensure there are no wireless devices listed in the "Setup", "Maintenance" and "Networking" menus.
- Ensure the cellular data modem is disabled in the system and physically disconnected via power and data cables.
- Ensure the Ethernet port on the shuffler is disabled in the menu.
- When using a laptop or other specifically authorized external tool to connect to the shuffler ensure compliance with WAC 230-16-151.

## <u>Requirements for House-Banked Card Room Licensees:</u>

- Ensure only approved card games, as posted on the WSGC website, are played using the shuffler.
- Ensure only approved equipment is connected to the shuffler (iScore Ultra). Access to all other equipment must be disabled in the network setup menu.
- Ensure the "Enable Network" setting is the Network Menu is only enabled when the iScore Ultra display is connected.
- Ensure all ethernet and USB service ports are sealed while the shuffler is in play and only accessed by authorized personnel.
- Ensure the cellular data modem is disabled in the system and physically disconnected via power and data cables.
- Ensure only one external tool (such as a laptop) is connected to the shuffler via the ethernet port at a time and ensure compliance with WAC 230-16-151. The shuffler should never be connected to any networking devices such as hubs, switches, or routers.
- Ensure any external tool connected to the shuffler has all wireless and Bluetooth functions disabled for the duration of the connection.

### **Tribal Casino Implementation:**

- For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by Washington State Gambling Commission.
- Ensure only approved card games, as posted on the WSGC website are played using the shuffler.
- Ensure only approved equipment is connected to the shuffler (iScore Ultra). Access to all other equipment must be disabled in the network setup menu.
- Ensure the "Enable Network" setting is the Network Menu is only enabled when the iScore Ultra display is connected.
- Ensure all ethernet and USB service ports are sealed while the shuffler is in play and only accessed by authorized personnel.
- Ensure the cellular data modem is disabled in the system and physically disconnected via power and data cables.

- Ensure only one external tool (such as a laptop) is connected to the shuffler via the ethernet port at a time. The shuffler should never be connected to any networking devices such as hubs, switches, or routers.
