Thank you for requesting approval of the upgrade to the Deck Mate 2 shuffler. We have completed our review of the Deck Mate 2 shuffler. The Deck Mate 2 shuffler upgrade is approved in Washington State for both tribal and commercial facilities.

The approval is contingent on the following requirements:

Manufacturer Requirements

- Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.
- When using a laptop or other specifically authorized external tool to connect to the shuffler, ensure compliance with WAC 230-16-151.
- Shuffle Connect technology is not approved for use with the shuffler.

Requirements for Card Room Licensees

• Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.

Tribal Casino Implementation

For Tribal Casinos, ensure internal controls and game rules are revised to include new
equipment and procedures, and approved by Tribal Gaming Agency and concurred with by
Washington State Gambling Commission.
