Dear Tiffini Cox:

Thank you for requesting approval to market the card game Supreme Pai Gow to Washington State commercial card rooms and Tribal casinos. Based on our review of the documentation we received from Galaxy Gaming, the Washington State Gambling Commission will approve the game under the conditions listed below:

- The game shall be played and operated under the terms and conditions set forth under the Supreme Pai Gow rules of play you provided and are enclosed.

Commercial Card Rooms

- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

Tribal Casinos

- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.
- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.

- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be certified by the state and licensed by the Tribe prior to the sale of the equipment.

Game Description

Supreme Pai Gow is a commission-free, house-banked Pai Gow poker-based game using a standard 52-card deck and a Joker. The object of the game is for the players to beat the dealer with both their 2-card low hand and their 5-card high hand. In *Supreme Pai Gow*, the dealer starts with eight cards to create their best 2-card low hand and 5-card high hand, however, players may raise up to 4x their *Ante* wager, and the *Ante* wager WINS ON PUSHES. Rules pertaining to standard Pai Gow Poker, stated in the approved rules of play posted on the WSGC website under "Authorized Games" are followed, except for those listed in these rules of play. *Supreme Pai Gow* also contains optional bonus wagers that are not dependent on the base game's outcome.

Casino operators choose which bonus wagers they will offer, subject to any restrictions contained within these Rules of Play. Each bonus wager may be made at the player's option and there is no effect on the primary game and no changes in player strategy. Minimum and maximum wagering limits are established by the casino operator in accordance with the limits set in WAC 230-15-040, WAC 230-15-140, or their specific regulatory body.

Rules of Play

1. To begin each round, each player must place an *Ante* wager and may place any of the available optional bonus and/or progressive wagers.
2. After all wagers are placed, each player is dealt four cards and the dealer is dealt eight cards. All cards being dealt face-down.
3. After examining their four cards, each player must decide to either:
 - a. **Play**, by placing a *Raise* wager equal to 1x to 4x their *Ante* wager. *Raise* wagers may not exceed maximum wagering limits.
 - b. **Fold**, and lose their *Ante* wager.
4. Each player that has placed a *Raise* wager will now receive their three remaining cards.
 - a. Players that have placed any optional bonus wager requiring their 7-card hand must be dealt their remaining three cards, regardless of whether they choose to raise or fold.
5. Each player must set a 2-card low hand and a 5-card high hand and place them in their designated spots on the layout. If the low hand is incorrectly set to be of greater value than the high hand, the hand is a foul and settled in accordance with house procedure.
6. Once all players have set their hands, the dealer will reveal their eight cards and set their 5-card high hand and 2-card low hand, according to the House Way, and slant the unused card (or otherwise place it in a designated spot on the layout).
 - a. Note that the dealer will always have one remaining/unused card, aka the 8th card.
 - b. If the *Dealer's 8th Card* optional bonus wager is configured, the 8th card is used to evaluate said bonus wager.
7. Each player's hands are compared to the dealer's respective hands and the *Ante* and *Raise* wagers are reconciled as follows:

- a. If *both* the player's hands are *higher than* the dealer's respective hands, the *Ante* and *Raise* wagers win and are paid 1 to 1.
 - b. If *both* the player's hands are *lower than or tie* the dealer's respective hands, the *Ante* and *Raise* wagers lose.
 - c. If one of the player's hands is *higher than* the dealer's respective hand and the other hand is *lower than or ties* the dealer's respective hand, the *Ante* wager wins and is paid 1 to 1 and the *Raise* wager pushes.
8. Regardless of the outcome of the *Ante* and *Raise* wagers, each player that has made a *Raise* wager is eligible to receive an *Ante Royalty* pay based on their 7-card hand, according to the corresponding payable in Appendix A.
 9. The dealer reconciles all optional bonus wagers.

Equipment

This game will use the Galaxy Gaming owned Andromeda Bonus Jackpot System Series 3d or higher. Jackpot meter displays will not contain additional intelligence or functionality, including but not limited to network capability, wired or wireless.

If operators use an automatic shuffle machine, it must be a WSGC approved model, manufactured by a WSGC licensed manufacturer.

Gambling Promotions

A gambling promotion may be added to any of the bonus wagers at the discretion of the casino operator and with the written consent of Galaxy Gaming.

Optional Bonus Wagers

Pai Gow Insurance (Felt)

Players win if their 7-card hand is a Pai Gow and are paid based on the corresponding payable in Appendix B.

Emperor's Treasure (with Envy Bonus)

Players win if their 7-card hand achieves a winning event based on the corresponding payable in Appendix C. *Emperor's Treasure* includes a bonus feature called *Envy Bonus*.

Envy Bonus

To qualify for an *Envy Bonus* prize, the player must place an *Emperor's Treasure* wager of \$5 or more per hand. A player's hand is awarded an *Envy Bonus* prize when another player's hand, at the same table, achieves a triggering event listed on the corresponding *Emperor's Treasure* payable. A player may be permitted to play more than one hand. If a player is playing more than one hand, then one of their hands may be used as the winning triggering event for the other hand. The player's hand that achieves the *Emperor's Treasure* triggering event is not awarded both an *Emperor's Treasure* prize and an *Envy Bonus*. This hand is only awarded the *Emperor's Treasure* prize.

7-Card Bonus

Players win if their 7-card hand achieves a winning event based on the corresponding payable in Appendix D.

Dealer's 8th Card

Three separate optional wagers, based on the value of the dealer's unused 8th card, that are paid according to the corresponding payable in Appendix E.

House and Progressive Jackpots

- Operators may choose to offer up to two jackpot game options on a layout using two independent wagering sensors and displaying two independent jackpot amounts
- Each jackpot sensor is considered a separate game
- Progressive Jackpots cannot be linked with House Jackpots
- All jackpots on a table must be of a single jackpot type (House or Progressive)
- Operators can only offer one jackpot game option per sensor

Pai Gow Insurance House or Progressive Jackpot

Players win if their 7-card hand is a Queen High Pai Gow or less and is paid based on the corresponding payable in Appendix F.

Emperor's Treasure House or Progressive Jackpot

Players win if their 7-card hand achieves a winning event based on the corresponding payable in Appendix G.

House or Progressive Jackpot Definition

If operated as a **House Jackpot** (also called a **Bonus Jackpot**), the table display does not increment after each wager is placed. All House Jackpot displays must include the following language: "House Jackpot prizes are paid by the casino and are not components of any progressive prize contest. Player wagers do not accrue to any guaranteed player fund. The displayed House Jackpot prize may be modified or discontinued at any time without prior notice."

If operated as a **Progressive Jackpot**, the table display should increment after each wager is placed. Casino operators must follow the rules contained in WAC 230-15-680 through WAC 230-15-720. Prizes displayed are considered to be held in escrow by the casino operator who acts as the custodian of the funds for the benefit of the players. Operators offering progressive jackpots must: (1) Ensure specific wager limits on progressive wagers to ensure all funds are accounted for; and (2) Maintain and account for all funds collected for progressive jackpot games.

The operator's internal controls must define how the Jackpots are configured and how they are won and if operated as a house or a progressive game.
