RE: Bravo Poker and Pit Systems

Dear Mr. Gorsche,

Thank you for requesting approval of the Bravo Poker and Pit Systems. We have completed our review.

The Bravo Poker and Pit Systems are approved for use in Washington State with the following requirements:

1. Genesis Gaming Solutions, Inc. is required to be a licensed manufacturer prior to the sale or lease of the Bravo Poker and/or Pit Systems.
2. The Bravo Poker Systems currently installed in both tribal and non-tribal commercial house banked cardroom casinos must be replaced with this approved version within 30 days of the date of this letter.
3. The Bravo Random Selector RNG software and/or Bravo Random Seat cannot be used in Washington non-tribal commercial cardrooms. This feature is not authorized by WAC 230-06-030- Restrictions and conditions for gambling promotions. This module cannot be included in the suite of software available to the non-tribal systems.
4. The Bravo Poker Kiosk Module software/hardware can only be used for waitlist sign up, sign up for promotions, or to view players' promotional status. The Kiosk cannot be used for cash/credit transactions in Washington casinos.
5. Prior to the Bravo Poker or Pit systems being connected to a Tribal Lottery System (TLS), the System(s) must be submitted, tested, and approved. Any connections to a TLS network would require a firewall.
6. If Bravo Pit or Poker Systems are connected to a casino network, they should be set up through the use of a firewall or VPN/switches to prevent remote access to the System(s) through the internet. Any data communications with the Poker Live App should be one way from Bravo Poker to Poker Live App.
7. Remote access to the System(s) through the internet for service, maintenance, updates, etc. is not authorized.



8. Internal controls should be in place for the Bravo Poker or Pit System prior to operation in a Tribal Casino or nontribal commercial House Banked Card Room. Permissions and access to different employee classes should be outlined in the internal controls and verified to prevent incompatible functions, manipulations, or cheating schemes. Access to SQL database should also be controlled and limited to authorized personnel through user access permissions and internal controls. Tribal casino internal controls should be approved by the Tribal Gaming Agency and concurred with by Washington State Gambling Commission.



Bravo Poker/Genesis must notify us prior to any installation/replacement in Washington so arrangements may be made for Agent inspection/review. At least 10 business days prior to installation, provide us with a list to include specific locations, dates, and times when this system will be installed.
