Re: i-Score Plus v1.7.0

Dear Mr. Zorn,

Thank you for requesting approval of the i-Score Plus v1.7.0 upgrade. We have completed our review.

The i-Score Plus v1.7.0 that works in conjunction with the i-Shoe Auto v2.0.141 (approved May 7, 2010), is approved for use in Washington State with Fortune 7, One Up!, Dragon Bonus, Dragon Bonus with Fortune 7 Progressive, and Fortune 7 Baccarat with Optional Progressive. We are approving the i-Score Plus v1.7.0 with the following requirements:

- A user login and password should be added to start up the PC Table Processor in order to limit access by unauthorized users.
- Disable the functionality that allows an automatic login when the device is powered on.
- If the optional i-Shoe Auto is used with the i-Score Plus, the keypad should only be attached to the i-Shoe during configuration of the display.
- If the optional i-Shoe Auto is used with the i-Score Plus all requirements associated with the i-Shoe Auto remain in effect.
- The i-Score Plus cannot be used with any other electronic or mechanical shoe, unless authorized and approved by us.
- The Windows 7 PC that runs the i-Score Plus includes several USB ports and a CD/DVD reader that should be sealed and secured during operation on the gaming floor. The Ethernet Port should also be sealed if no i-Shoe is connected to the i-Score during operation.



- Because the Super 6 optional wager was not submitted for testing and is not currently approved in any game rules in Washington, the Super 6 optional wager configuration in the i-Score Plus menu must be disabled at all times.
