**RE: Nexus Command – Table Controller Hardware, Table Controller Software v2.0,
and Game Manager Software v1.3**

Dear Ms. Kimball:

Thank you for requesting approval of the Nexus Command – Table Controller Hardware, Table Controller Software v2.0, and Game Manager Software v1.3 (Nexus Command). We have completed our review.

The Nexus Command is approved for use in Washington. We are approving the Nexus Command with the following requirements:

You must:

- Provide a lockable barrier, container, or seal for USB and Ethernet ports on the minicomputer. Though the computer has aluminum housing and is protected by the internal door switch, there are multiple USB and Ethernet ports that are accessible.
- Not connect external tools to the Game Manager computer or the minicomputer for standard maintenance until authorized by the Washington Administrative Code (WAC).
- Maintain the .ini file setting for a stand-alone progressive environment only. The Operator Wide Area Progressive (O.W.A.P) system was not tested and is not allowed in Washington.
- Update your game rules for games that will use Nexus Command prior to installing the equipment in Washington.



The operator must:

- Maintain a closed gambling equipment system that is isolated from non-gambling systems; and inaccessible from outside networks.
- Connect gaming tables to the system by standard computer network connections, and not use wireless connections.
- Limit access to the Nexus Command System. All unused ports on the Game Manager computer and the minicomputer must be sealed to prevent unauthorized access.
- Limit access to the Table Controller by providing individual access cards. The access levels must be included in their Internal Controls.
- Identify in their Internal Controls if they are using the standard jackpot calculation method or the optional jackpot configuration method. All progressive jackpot WAC rules must be followed.
- Include any primary jackpot cap amounts in their Internal Controls.
- Ensure chips are placed on the center of the sensor to ensure all wagers are accurately recorded.

Tribal Casino Implementation:

- For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred by us.


