Dear Mr. Stevens,

Thank you for requesting approval of the Pax S Shuffler. We have completed our review.

The Pax S Shuffler is approved for use in Washington State. The approval is contingent on the following requirements.

Manufacturer Requirements:

- Ensure licensees are aware of the issue noted during testing. Specifically, if a supervisor accesses the hand recall menu while cards are in the shuffler and then exits and changes the game, the shuffler will not record the hand that was dealt, and no errors are recorded in the logs. This issue will be fixed in the next update to the shuffler software.

Requirements for House-Banked Card Game Licensees:

- Be advised of the issue noted during testing. Specifically, if a supervisor accesses the hand recall menu while cards are in the shuffler and then exits and changes the game, the shuffler will not record the hand that was dealt, and no errors are recorded in the logs. This issue can be prevented if access to the User Menu is only allowed when the shuffler is not in play. This issue will be fixed in the next update to the shuffler software.
- Ensure only approved card games, as posted on the WSGC website, are played using the shuffler.
- Ensure any unused USB ports and Ethernet ports are sealed or covered during operation.

Tribal Casino Implementation:

- Be advised of the issue noted during testing. Specifically, if a supervisor accesses the hand recall menu while cards are in the shuffler and then exits and changes the game, the shuffler will not record the hand that was dealt, and no errors are recorded in the logs. This issue can be prevented if access to the User Menu is only allowed when the shuffler is not in play. This issue will be fixed in the next update to the shuffler software.

October 10, 2022

- Ensure only approved card games, as posted on the WSGC website, are played using the shuffler.
- Ensure any unused USB ports and Ethernet ports are sealed or covered during operation.
