RE: Updated approval for Deck Mate 2 Shuffler, Part Number DU2200 and DU2326

Dear Ms. Hunter,

Pursuant to the recent approval of WAC 230-16-152, we are approving Deck Mate 2, Part Number DU2326 which designates the Deck Mate 2 Shuffler with the Flex Cellular Modem, and Deck Mate 2, Part Number DU2200 which designates the Deck Mate 2 Shuffler without the Flex Cellular Modem in Washington State.

Deck Mate 2 Shuffler, Part Number DU2326 and Deck Mate 2 Shuffler, Part Number DU2200, may be operated as a shuffler in Washington State. The approval is contingent on the following requirements:

Manufacturer Requirements:

- Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.
- When using a laptop or other specifically authorized external tool to connect to the shuffler ensure compliance with WAC 230-16-151.

Operator Requirements:

- Ensure Ethernet and USB ports are sealed or covered during operation of the shuffler.

Tribal Casino Implementation:

- For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by Washington State Gambling Commission.
