Dear Mr. Robinson,

Thank you for requesting approval of Scientific Games i-Deal Plus Shuffler. We have completed our review. The Scientific Games i-Deal Plus Shuffler is approved for use in Washington State Tribal Casinos.

Approval of the i-Deal Plus Shuffler is contingent on the following requirements:

Manufacturer Requirements:

- Connection to Shufflelink server was not submitted for testing and is not approved at this time
- Connection to iTable and Fusion Hybrid was not submitted for testing and is not approved at this time
- Ensure no wireless keyboards are attached to the shuffler
- Any PIN numbers needed to access the shuffler's configuration and setup menu are not to be shared with non-SHFL Entertainment employees and are only to be used by SHFL Entertainment Field Technician's.
- The Enable Network setting in the Network Menu must be set to "Disabled" before the shuffler is put into play to ensure the device is secure and avoid any potential security risks.

Tribal Casino Implementation:

- Ensure internal controls are revised to include new equipment, and procedures and are approved by the Tribal Gaming Agency, and concurred with by the Washington State Gambling Commission.

- Ensure game rules are revised to include games approved for use with the i-Deal shuffler to be offered and are approved by the Tribal Gaming Agency and concurred with by the Washington State Gambling Commission.

Any modifications made to the Scientific Games i-Deal Plus Shuffler must be submitted to us for additional testing and review. We reserve the right to investigate and re-evaluate this equipment if we determine that such a review is necessary to ensure compliance with tribal state compacts or rules and laws of Washington.

Please notify Special Agent Julie Kerkof at Julie.kerkof@wsgc.wa.gov at least 2 weeks prior to any scheduled installation of the i-Deal Plus Shuffler into a tribal casino.
