Dear Ms. Rodriguez,

Thank you for requesting approval of the Scientific Games i Deal Plus Shuffler. We have completed our review.

The i Deal Plus Shuffler is approved for use in commercial house-banked card rooms in Washington State. The approval is contingent on the following requirements:

Manufacturer Requirements:

- Connection to Shufflelink server was not submitted for testing and is not approved at this time.
- Connection to iTable and Fusion Hybrid was not submitted for testing and is not approved at this time.
- Ensure no wireless keyboards are attached to the shuffler.
- Any PIN numbers needed to access the shuffler's configuration and setup menu are not to be shared with non-Scientific Games employees and are only to be used by Scientific Games Field Technicians.
- The Enable Network setting in the Network Menu must be set to "Disabled" before the shuffler is put into play to ensure the device is secure and avoid any potential security risks.

Operator Requirements:

- Ensure only approved card games, as posted on the WSGC website, are played.
- Ensure the table betting limits and pay tables displayed on the shuffler agree with your approved internal controls and approved game rules.


