RE: iVerify Display v. 1.0.026 when used together with the iDeal Shuffler v. 3.8.084

Dear Ms. Zarach,

Thank you for requesting approval to use the iVerify Display v. 1.0.026 with the iDeal Shuffler v. 3.8.084 for Face Up Pai Gow Poker. It is our understanding that there have been no software changes for the iDeal Shuffler v. 3.8.084 and iVerify Display v. 1.0.026 in seeking this request.

We are approving the iVerify Display only when used together with the iDeal Shuffler v. 3.8.084 (iDeal) with the following requirements:

iDeal Shuffler v. 3.8.084:

- The dealer cannot access the iDeal screen menu; only a supervisor or above should be able to access password protected areas of the screen menu.
- The Ethernet ports on the iDeal were disabled and not operational during testing. Therefore, no Ethernet connectivity should be seen on this shuffler in Washington State.
- Only authorized Bally Technologies technicians may use the proprietary USB flash drives for updating software and diagnostic testing of the shuffler in compliance with WAC 230-16-151.

iVerify Display v. 1.0.026 only when used with the iDeal Single Deck Shuffler v. 3.8.084:

- Licensees who use the iDeal with the iVerify Display, must ensure all other players at the table have set their hands before using the iVerify Display to set a player's hand "house way," except when dealing Face Up Pai Gow where the dealer receives their cards face up.
- Dealers must not access the iVerify Display to reveal the dealer "house way" until all players at the table have set their hands or had their hand set "house way," except when dealing Face Up Pai Gow Poker where the dealer receives their cards face up.



- Licensees and Tribal casinos must ensure the iVerify Display can be viewed by surveillance as required in WAC 230-15-280 and Tribal-State Compacts.
- Only the following games are approved to be used with the iVerify Display: Pai Gow, Fortune Pai Gow Poker, Fortune Pai Gow Poker Progressive, Fortune San Lo Poker, and Fortune Asia Poker.
- Upon submission and approval of game rules indicating the use of this equipment, the iVerify will be approved for use with Face Up Pai Gow Poker.

Thank you for requesting approval of the i-Deal shuffler upgrade with i-Verify Display. We have completed our review.

We are approving the i-Deal Single Deck Shuffler version 3.8.084 with i-Verify Display version 1.0.026 with the following requirements:

i-Deal Single Deck Shuffler v. 3.8.084:

- The dealer cannot access the i-Deal screen menu; only a supervisor or above should be able to access password protected areas of the screen menu.
- The Ethernet ports on the i-Deal were disabled and not operational during testing. Therefore, there should be no Ethernet connectivity on this shuffler in Washington State.
- Only authorized Bally technicians may use the Bally proprietary USB flash drives for updating software and diagnostic testing of the shuffler in compliance with WAC 230-16-151.

i-Verify Display v 1.0.026:

- Licensees who use the i-Deal with the i-Verify Display, must ensure all other players at the table have set their hands before using the i-Verify Display to set a player's hand "house way."
- Dealers must not access the i-Verify Display to reveal the dealer "house way" until all players at the table have set their hands or had their hand set "house way".
- Licensees and Tribal casinos must ensure the i-Verify Display can be viewed by surveillance as required in WAC 230-15-280 and Tribal-State Compacts.
- Only games approved for use with the i-Verify Display may be operated in WA.




