ORDER DENYING PETITION FOR  
REVIEW AND FINAL ORDER


THIS MATTER came before the undersigned Commissioners of the Washington State Gambling Commission (“Commission”) at the Commission’s regularly scheduled meeting on July 17, 2020, held via teleconference in Olympia, Washington, on Mr. Doo’s and Mr. Mazeckin’s Petition for Review of the Administrative Law Judge’s April 13, 2020 Initial Order. Mr. Terence Wong, Attorney, represented both Mr. Doo and Mr. Mazeckin. Assistant Attorney General Doug Van De Brake represented the Washington State Gambling Commission’s agency staff. The Commission had before it the record of the prior proceedings relating to this matter, as well as additional pleadings prepared for this petition for review. Oral argument was held.

Following oral argument and review of the record, the Commission DENIES Mr. Doo’s and Mr. Mazeckin’s Petition for Review. The Commission AFFIRMS in its entirety the April 13, 2019 Initial Order Granting Gambling Commission’s Motion for Summary Judgment and adopts the Initial Order as the Commission’s Final Order.
