The Washington State Gambling Commission (WSGC) represented by its Director, DAVID TRUJILLO, and the Applicant, CENTRAL VALLEY BEAR BOOSTER CLUB (Applicant), represented by its President, SCOTT GABBERT, hereby enter into this stipulation and settlement agreement for Case Number CR 2019-01996

I. INTRODUCTION

In the above-referenced case, the Washington State Gambling Commission issued a Denial of Raffle Application dated December 20, 2019, alleging that Applicant was not qualified for licensure.

II. AGREEMENT OF THE PARTIES

The Washington State Gambling Commission and the Applicant agree to the following:

1. The Washington State Gambling Commission and the Applicant enter into this agreement to avoid the time and expense of further litigation.
2. The Applicant explicitly waives the right of further administrative review of all matters related to the above-referenced Denial of Raffle Application and waives its right to a hearing in this matter.

1 3. The parties stipulate that the Applicant allowed its previous Raffle license to
2 lapse, effective June 30, 2019.

3 4. The Applicant stipulates that it conducted a raffle with a drawing date of October
4 4, 2019.

5 5. The parties stipulate that the Applicant did not have the valid license required to
6 conduct the gambling activity that it did for the October 4, 2019 raffle.

7 6. The parties stipulate that the application that was completed by, and submitted
8 by, the Applicant on October 18, 2019 was done so properly.

9 7. The parties stipulate that the Applicant conducted an unlicensed, and thus illegal,
10 gambling activity in the form of the October 2019 raffle. But for this, the Applicant would have
11 been approved for licensure.

12 8. The parties agree that the Washington State Gambling Commission will consider
13 that the violations set forth in the Denial of Raffle Application, as specified in the above
14 paragraphs, have been sustained and will become a part of the Licensee's licensing record.

15 9. In consideration for the Applicant's admissions and willingness to enter into this
16 agreement, the Applicant shall pay a monetary penalty of \$8,000 no later than January 3, 2020
17 by mailing or delivering payment to the Commission Headquarters at the following address:


 10. Once the Applicant makes its payment, the application will be forwarded for
approval.

1 11. Provided Applicant completes payment in a timely manner, the license to be
2 issued will be effective starting the first quarter of 2020. Applicant will not need to take any
3 additional steps, specifically Applicant will not be required to file a quarterly license report or
4 pay fees for fourth quarter of 2019, to be in full compliance.

5 12. Upon issuance of a valid license, Applicant will be subject to all requirements of
6 licensees, including filing of quarterly license reports and fees, effective immediately.

7 13. Applicant's failure to timely make its payment will result in staff proceeding with
8 the formal Denial of the Raffle Application.


9 14. This agreement constitutes the final written expression of all the terms of this
