Concise Explanatory Statement

You are receiving this notice because you commented or participated in a workgroup on these proposed rule changes:

Notice of Permanent Rules to Allow a Two-Person Team Conduct a Soft Count if Licensees Uses a Currency Counter

This explanatory statement concerns the Washington State Gambling Commission's adoption of:

- WAC 230-15-610 Preparing to conduct a count
- WAC 230-15-615 Conducting the count

The Administrative Procedure Act (<u>RCW 34.05.325(6)</u>) requires agencies to complete a concise explanatory statement before filing adopted rules with the Office of the Code Reviser. This statement must be provided to anyone who provided comments regarding the proposed rule-making.

Once persons who provided comments during this rulemaking have had an opportunity to receive this document, the Washington State Gambling Commission will file the amended rules with the Office of the Code Reviser. These changes will become effective on January 1, 2019.

What are the agency's reasons for adopting this rule?

This rule change allows a card room to have two people, instead of three, conduct a soft count if:

- Card game gross gambling receipts were less than \$5 million in the previous fiscal year,
 or
- Card game gross gambling receipts were between \$5 million and \$15 million and the licensees use a currency counter.

New house-banked card rooms must have a three-person count team until the licensee submits financial statements to the Washington State Gambling Commission indicating their card room gross gambling receipts in the previous year. A summary of rule changes is provided in Table 1.

Public Comment:

An email was received from Phil Ziegler, Emerald Downs, on August 3, 2018 in favor of these changes. Washington State Gambling Commission did not respond.

Victor Mena, Washington Gold Casinos, spoke in support of the new rule language at the Commission Meeting held on September 13, 2018, stating that each of his properties may save \$1,000 in payroll, which is significant for his card rooms. Washington State Gambling Commission did not respond.
